#### General Terms and Conditions of Sales via Internet Channels

#### 1 Definitions

- 1.1 'Seller' the entity offering its products on the Vente-Unique marketplace.
- 1.2. 'Buyer' the natural person, legal entity or organisational unit purchasing products through the Vente-Unique marketplace.
- 1.3. 'Marketplace' Vente-Unique's online platform allowing Sellers to showcase and sell their products.
- 1.4. 'Product' the goods offered by a Seller on the Vente-Unique platform.
- 1.5 'Terms and Conditions' these General Terms and Conditions of Sale.

### 2 Scope of the Terms and Conditions

- 2.1 These Terms and Conditions set out the rules for the conclusion and performance of sales contracts between the Seller and the Buyer through the Vente-Unique marketplace.
- 2.2 The Buyer accepts these Terms and Conditions when placing an order.

#### 3 Offer and Orders

- 3.1 All products presented on the platform are offers for sale.
- 3.2 An order is considered to be effectively placed once the order form has been completed and confirmed.
- 3.3 The Seller reserves the right to verify an order before its execution.

### 4 Prices and Payment

- 4.1 All prices indicated on the platform are gross prices and include VAT.
- 4.2 Delivery costs are indicated separately and added to the price of the Product.
- 4.3 The available payment methods are specified on the marketplace page when placing an order.

## 5 Delivery and Collection

- 5.1 The Seller will deliver the Products to the address indicated by the Buyer.
- 5.2 The delivery period is specified in the Product description. In case of delays, the Buyer will be informed immediately.
- 5.3 The risk of loss of or damage to the Product shall pass to the Buyer upon receipt of the Product.

## 6 Right of withdrawal

- 6.1 The Buyer who is a consumer has the right to withdraw from the contract within 14 days of receiving the Product without giving any reason.
- 6.2 In order to exercise the right of withdrawal, the Buyer should make a declaration in writing or electronically.
- 6.3 The Buyer is obliged to return the Product intact to the address indicated by the Seller.

#### 7 Complaints and Warranty

- 7.1 The Buyer has the right to make a complaint if the Product does not comply with the agreement.
- 7.2 Complaints should be submitted through the complaint form available on the platform or in any other way indicated by the Seller.
- 7.3 The Seller agrees to consider the complaint within 14 days of its receipt.

## 8 Personal data protection

- 8.1 The Seller shall process the Buyers' personal data in accordance with the applicable legislation on personal data protection.
- 8.2 Detailed information regarding the processing of personal data can be found in the Privacy Policy of

the Vente-Unique platform.

# 9 Final provisions

- 9.1 These Terms and Conditions shall be governed by the laws of the country in which the Seller operates.
- 9.2 Any disputes arising from these Terms and Conditions will be resolved by the competent local courts.
- 9.3 The Terms and Conditions may be amended by the Seller. The Purchasers will be informed about any changes in advance.
